1 Creek Street Christian College Vision, Mission and Philosophy Statements

Guidance	Action to mitigate the introduction and spread of COVID-19
Hygiene	
Provide and promote hand sanitiser stations for use on entering building and other locations in the worksite and ensure adequate supplies of hand soap and paper towels are available for staff.	All entrances to the school are staffed with staff having bottles of hand sanitiser and thermometers. Staff and students have temperatures checked upon first entry to the campus and hands are sprayed with sanitiser. In addition, hand sanitising dispensers are located throughout the campus and students' hands are sanitised each time they come into a new room and after recess and lunch. As of the commencement of the 2021 school year we will now sanitise hands as students come into classrooms only. Visitors and staff hand sanitise as they enter the college. No temperature checks required. 3 June 2021 – The same process will be in place as we return from our current lockdown period. 7 October 2021 – The same process is currently in place as indicated above. Staff and reminded daily in morning briefings regarding self-care, as well as caring for students. 2 November 2021 – Same as above. 8 February 2022 – Same as above, however, initially, at the start of the 2022 College year, students will be met at the college gates by staff, where their temperatures will be taken and hands sprayed with hand sanitiser. Staff will only use the front main entrance and go through the same process as the students. Anyone found to have a temperature above 37.5 will be re-checked in 15 mins. If below 37.5 at the re-check, they will be allowed to enter the campus and parents will be called to collect their student. Staff will be advised to go home and follow other require COVID procedures. April 2022 - As of the commencement of Term 2, 2022, we will now sanitise hands as students come into classrooms only. Visitors and staff hand sanitise as they enter the college. No temperature checks required.
Where possible: enhance airflow by opening windows and adjusting air conditioning.	Administrative areas and classrooms have independent aircon/heating units. Weather permitting, staff will be asked to open windows and doors to encourage airflow to reduce viral spread. Continued 2021 3 June 2021 – Where possible, weather dependent, this will be accomplished. 7 October 2021 – As above. The BenQ screens have a CO² monitor displayed which is an indicated of airflow in a particular room. If not green, then increase airflow in the room or move outside, weather dependent. 2 November 2021 – Same as above. The government supplied air purifiers are on their way and will be installed in the rooms which have the greatest need for better air flow and don't have the BenQ screens (Rooms 7, 8 and 9) 8 February 2022 – same as above, however, additional air purifiers have been received (approximately 20) and they have been placed in majority of classrooms and high-traffic areas. April 2022 – Same as above. All teaching spaces have air purifiers.
In areas or workplaces where it is required, ensure all staff wear a face covering and/or required PPE, unless a lawful exception applies. Ensure adequate face coverings and PPE are available to staff that do not have their own.	All staff wear masks as mandated. Those with exemptions were asked to provide a medical certificate and were encouraged to wear shields. Staff who cannot orovide a medical certificate are allowed to work from home with permission of the College Principal. Additional face masks are available from the College reception to be used as necessary. As per guidance issued by State Government, all students 12 and older and staff and adults on the premises are require to wear masks- unless and exemption in writing is notified to the College Principal. 3 June 2021 – All staff and students will be required to wear masks inside and encouraged to wear masks outside when unable to correctly socially distance (1.5 metres apart) 7 October 2021 – Face covering requirements remain the same. Students under 12 years of age are commend to wear facemasks, but it no compulsory at this time. 2 November 2021 – Students in Year 3 to 11 are now required to wear face masks while indoors only. This began on 1 November 2021. 8 February 2022 - same as above. Students and staff will be encouraged to wear face masks outside as well if they cannot maintain a safe social distance form others. The College is also making available N95 masks for staff who want them and a supply of smaller masks for students. N95 masks will be required to be

worn if staff are an educational contact of a positive case or are regularly involved in first aid of students. It is recommended cloth masks not be worn. April 2022 – No masks required. Optional. Documentation provided by the Government on how to correctly wear, use and dispose of face coverings was provided to all staff. Each staff member was provided with disposable face masks and a College monogramed facemask (cloth). New students and staff in 2021 have been issued with College monogramed face masks. The number of rooms and learning spaces used on campus have been lessened to reduce the need for additional cleaning given the reduced number of students on campus. An increase in cleaning (at least twice daily) will occur once all staff and students return to campus for normal classes. Cleaning kits have been placed in each classroom for staff to use on high touch areas during the day and as needed. Discontinued and once daily cleaning. 	The College has worked with staff to move as many off premises as reasonably possible while ensuring it can meet its OH&S obligations, provide continuity of learning and attend to the supervision of students belonging to permitted workers.
	Full-time staff have reduced their attendance onsite with the overlap minimised within areas. Staff have been rostered on staggering days to reduce exposure to all.
	Staff on site are here for supervision, security or operational reasons.
Ensure that all staff that can work from nome, do work from home.	Staff will return to the College Campus when remote and flexible learning ends at the start of Term Four. All staff have returned to on site learning in 2021. There are density limits in staff lunchroom and staff office. At the commencement of the year we have minimised the number of staff in classrooms to two whenever practical.
	3 June 2021 – All staff will return to on-site teaching on 4 June 2021. When staff return, they will be reminded to socially distance as much as possible, to reduce larger gatherings in staff work and break areas by staggering break times, and to be generally mindful of the number of staff/students in once place, with the exception of classrooms.
	7 October 2021 – Some teaching staff have started to return to on-site learning as per government guidelines, with the majority of staff returning on Monday, 11 October 2021.

All staff and students are temperature checked upon entry with entry points staffed at the beginning of the day. Visitors/contractors to the College are kept to a minimum and are temperature checked upon entry via the College reception. Those who have high temperatures (37.5 or above) or appear unwell are sent home. Staff are strongly encouraged to have a COVID test if symptomatic. If a test is conducted, staff and students are not permitted to return until a negative test result is received. **No longer** required but temperature checks can be used if students or staff exhibit symptoms. 3 June 2021 – Temperature checks have not been directed by the Department or ISV at this time. The College has the ability to check these as required/requested. 7 October 2021 – Temp checks are no longer advised, but the College can institute this again quickly if needed.

2 November 2021 – Same as 7 October 2021.

3 February 2022 – Temperature checks will commence again at the start of Term One, 2022 and continue at least for the first four weeks. Rapid Antigen Tests have also been given to students and staff, with the suggestion that checks be conducted twice weekly during the work week. -

April 2022 - Same as October 2021. To be reviewed as needed.

All staff, students and visitors are required to hand sanitise before entering buildings and throughout the day, when needed.

3 June 2021 - All staff are asked to sanitise hands before and when entering rooms and break areas. Students are required to wash hands or have hands sanitised

All visitors entering the site have access to this COVID-safe plan and are asked to answer specific questions regarding their contact with others and wellness. Sign in procedure maintained in 2021. Cleaning for onsite during the day will continue as previously listed by regularly wiping down surfaces and high touch points. Cleaning/disinfecting will also continue for all areas being used and could be increased to occur more frequently if needed.

3 June 2021 – Restricted use of toilets was in-place for on-site staff and students during the circuit breaker lockdown; these will be lifted when staff/students return on 4 June 2021, however, students will be reminded again of designated toileting areas based on Year level.

2 November 2021 – In October, extensive cleaning was undertaken after a positive case of COVID at the College.

8 February 2022 – The College is cleaned each day after staff and students depart. Additional cleaning will be undertaken as needed based on any positive cases that arise. We are praying there will be no closures in 2022.

April 2022 – Same as above.

Should there be a confirmed case of an employee during work hours, the College will enact its COVID-19 confirmed case policy. The individual will be isolated and/or sent home dependent on how sick they are. If the individual is too sick to leave, any staff providing care will be required to use appropriate PPE equipment.

Onsite staff/students will be sent home and any close contacts will be notified to have COVID testing done and to self-isolate in line with current government guidelines. This will be done without breaching the privacy of the individual.

The College will be shut down for the period advised by DHHS and all areas that have been entered by the individual will be subject to a deep cleaning process. DHHS, WorkSafe and all necessary authorities governing schools will be notified.
